Governance Committee

Our current tasks are scouring the P&Ps to see the references to officiating that might need to be changed due to R9. Our goal is to have that done by the end of the March. April we will work on tackling succession planning.

<u>Camps</u>

Age Group Select Camp will be held April 21 in Lake Oswego. We have Olivia Carter as our swimmer clinician in the morning, and we will have stations in the afternoon. Camp invites will be sent out in mid March – swimmers will be selected from performances done at 10 & U and 11 to 14 champs. 8 girls and 8 boys from each age group 10,11,12,13 & 14 will be invited in mid-April. Cost is minimal to attendees. We will be needing coaching helpers and will be asking for helpers soon.

<u>TPC</u>

Have heard feedback from coaches and officials about 10 & Under Champs and the crowded conditions. Finding creative ways to address overcrowding should be a priority this fall as we look to the future and keeping kids in our sport. The summer long course meet information documents are beginning to be looked at, with the goal of having the meet information available for summer champs meets in April.

Age Group Chair – Alexandra Tokman

• Meet information: the meet information that was sent out by the Official did not come from an O.S.I. email or the host team's email. It came from Teamsters Local Union 670 and went to SPAM. It should come from, at a minimum, the host team's email.

• Entries: Now that we have some data, post Covid, it looks like we may need to adjust the time standard to A times only or maybe allow the top 24 times to enter the event = 3 heats of 8 swimmers.

• Warm-ups: Due to the amount of athletes and no designated lanes for teams to warm-up in (my opinion a HUGE safety issue), we need to create a Flight 1 and Flight 2 for the 1 hour 30 minute warm-up time. Keep lane 1 as an 8 and Under lane. Have teams assigned to lanes. They get 45 min. to do their warm-up and starts in their own lane. When time is up, 2nd flight of kids get in and repeat above. Smaller teams can be combined. Coaches can work out when to begin starts themselves who are assigned to that lane.

• Warm-up/Cool Down Pool: this ended up being a glorified Rec Swim. Definitely a safety concern for those trying to use the pool for warm-up or cool down. The ultimate was when this pool was closed because someone pooped in it.

• Deck: Many athletes were running on deck. The lifeguard was yelling to "Walk Please" and no one was following their directions.

• In the athlete area: teams need 1 engaged, observant, disciplining chaperone to every 10 swimmers (age 9-10) or 1 to 7 (for 8 and under). Many parents were on their phones, not paying any attention to the kids they were supposed to be supervising.

• *Prior to going to the meet, O.S.I. could send out a survey monkey to find out who will be the coach on deck, contact info., etc. The survey could also get the names of timers, officials, and chaperones from each team. No name on the list = no early entry. Early entry does NOT mean you get to reserve seats for other parents. It means you have volunteered for a job to do. This needed to be monitored.

• Safety: There needs to be a monitor for unauthorized parents in the athlete zone. Someone who is not afraid of telling parents to leave the area.

• Concessions and the T Shirt vendor should have been outside. This would free up more space for spectators.

• Toys: Some teams had clapper hands and were rattling them behind the blocks. Others had duck quacker whistle toys. These should be banned. It was already too noisy on deck and it was

hard to hear the starting system. It was brought it up with the head official.

• Safety: There were no signs reminding people about no cameras behind the blocks. One mom was even standing on the hot tub behind the blocks videoing her swimmer. An official was called over for support. The official tugged on the lady's pants. The lady continued to video until her child finished the race. (Absolutely ignoring the official.) In my opinion, this lady should have been escorted out of the building but was not.

• Safety: Cell phones being used behind the blocks. Still an issue, parents and coaches need to Keep it in your pocket or move to the side of the pool to use it.

• Safety: Did not hear any announcements about Safe Sport guidelines and expectations.

• Scoreboard: The ET Officials were changing the names and heats too quickly. It should be changed AFTER the start of the heat and not before.

• Awards: I had 2 kids earn 13th place in their event. After checking our ribbons, I noticed they had received 12th place ribbons. I went to the awards area and talked with the adult behind the table and explained what had happened. I was hoping to have it corrected. I was told that they "RAN OUT" of 13th place ribbons so they gave out 12th place ribbons instead. How does this happen? Did we not order enough?

• One coach did not have the e-mail sent to the correct e-mail address.

• Parents have the right to watch their swimmers compete-they do pay the bills. To be kicked out on the first day was unfair. The meet information said the facility can hold up to 400 people- but someone from the host team was kicking people out saying only 200 could be in the building. parents noted that there were not enough restrooms available.

Is renting Osborn Aquatic Center an option for 10 and under? Parents enter the front doors. Athletes, coaches and officials enter the side gated area. Volunteers for timing and team chaperones have names on a list at the clerk of course. Coaches, timers and chaperones must wear a lanyard for identification. No lanyard = no pool deck access.

Idea: O.S.I. could rent the facility and timing system. The host could be any team wanting to host the meet. (The meet is just held in Corvallis.) The host team would submit a "plan" explaining their ideas for how the meet should be run. Best ideas win the rights to hosting the meet.

On the plus side: Overall, the actual meet ran very well. We were slightly ahead of the timeline which is always a plus!
