

MEET NAME: 2013 Oregon Swimming Crater Lake Open

Altitude: 6,176 feet

Eligibility: Swimmers must be currently registered with USA Swimming. NO ON DECK REGISTRATION SHALL BE PERMITTED. Swimmers must be within the listed age brackets as of (the first day of the meet).

Entry Deadline: Entries must be received by 5:00 pm, December 25, 2013. Entries will be accepted first come first served, and will be no longer be accepted when session 1 is filled to capacity (4 hours duration).

Entry Limit: Swimmers may enter a maximum of two events excluding relays.

Events: All events are timed finals.

Entry Fees: \$3.00 Oregon Swimming surcharge per swimmer

\$2.00 individual event fee

\$8.00 relay entry fee

Entry Address: Santa Claus, North Pole

Entries: Submit YARD TIMES only for seeding, converted times are acceptable.

Submit entries in Hy-tek Meet Management format via email to Entry Address. Please attach DOC or PDF of Hy-tek entries.

With submission of entries, the coach/team representative attests that all swimmers entered are registered with USA Swimming.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing racing starts or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

No Coach Present: For unattached swimmers, or swimmers whose coach is not attending the meet, it is the swimmers responsibility to arrange for a certified coach to be responsible for the swimmer. This must be done **BEFORE** the swimmer may enter the water for warm-ups or competition. Please see the Meet Director or the Meet Referee if assistance is needed, upon arrival at the meet.

Facility: Outdoor, 25 yards x 30 meters, 10 lanes 7 1/2 feet per lane, Starting blocks at the deep end of the pool only (10 ft.) Shallow end is greater than 1000 ft deep. Electronic timing with touch pads at both ends will be used with Colorado 5 timing console.

The competition course has been certified in accordance with 104.2.2(c)4. A copy of such certification is on file with USA Swimming. Parking available, seating for 500 spectators after a long hike. Swim venue includes: Men's and Women's changing tents with access onto the pool deck; Open pool deck areas available for swimmers, coaches and officials only. Facility is not accessible to adaptive swimmers. This is not a real swim meet and is for practice purposes only.

**Restrictions: TOBACCO PRODUCTS OF ANY KIND, ALCOHOLIC BEVERAGES and GLASS CONTAINERS ARE NOT ALLOWED IN**

THE SWIMMING VENUE. NO SHAVING. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms

Times: Session 1 - 12 and under      warm up 7:30 am  
meet starts: 8:30 am

The 4 hour rule will be in effect for this session. All events will be pre-seeded.

Session 2 - 13 and over      warm up 1:00pm  
meet starts 2:00 pm

All ages will be swum together, but 13-14, and 15 & Over will be scored separately. Relays will be scored as one age group. All events will be pre-seeded except the 500 free which will be deck seeded. Positive check in for the 500 free is required by 2:00 pm. The 500 free will be swum fast to slow.

Rules: Current USA Swimming and Oregon Swimming Inc., rules will govern this meet.

Safety: Current Oregon Swimming Safety Guidelines and Warm-up Procedures will be in effect and strictly enforced.

Bull Pen: A bullpen will be provided for all 8&UN swimmers. All other swimmers shall report directly to their assigned lanes.

Awards: Individual: 1st thru 10th: Ribbons

Relays: 1st thru 3rd: Ribbons

High point (each age group): 1st thru 3rd: trophies

Scoring: Individual: 11-9-8-7-6-5-4-3-2-1

Relays: 22-18-16-14-12-10-8-6-4-2

Meeting: Coaches' meeting will be held 15 minutes prior to the start of the meet. Officials meeting will be held at 7:45 am (allow 30 minutes for the Officials meeting.)
