- 1) Submit **Short Course Yard TIMES** only for seeding. NT's are acceptable
- 2) Submit entries by email using HYTEK meet management software. Please include a PRINTOUT of your entries, listed by Athlete. Be sure the printout matches the entry file. 3) Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing racing starts or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

NO COACH PRESENT: For unattached swimmers, or swimmers whose coach is not attending the meet, it is the swimmer's responsibility to arrange for a certified coach to be responsible for the swimmer. This must be done BEFORE the swimmer may enter the water for warm-ups or competition. Please see the Meet Director or the Meet Referee if assistance is needed upon arrival at the pool.

TIMELIINE:

30 minutes of general warmup. During general warmup procedures, teams may open their own lane for diving at their own discretion. Coach much be present at all times during diving practice.

CHECK-IN:

Current credentials will be required. Please show coaching credentials to MR at coach meeting.

SCRATCHES:

Scratches must be presented to the admin ref by 1:15pm. There is No Penalty for a swimmer's no show. Any Scratched athletes given to Meet director prior to entry deadline of midnight on November 8, 2023 will not be charged. Scratches done after the entry deadline are charged at the discretion of the meet director.

MEETINGS:

OFFICIALS: Held 60 minutes before the start of the session. COACHES: Held 10 minutes before the start of the session.

OFFICIALS:

We always appreciate the help of certified officials from other clubs. If you will be attending this meet, please notify the meet referee. An official's hospitality area will be provided.

TIMERS:

Each team will be given lane-timing assignments. Sign-up sheets will be emailed to each team to fill lanes BEFORE the first day of the meet.

AWARDS:

Ribbons 1-8 for age groups 8under, 9-10, 11-12, 13-14, 15over.

BULLPEN:

NONE – All swimmers report directly to their lanes.

RULES:

Current USA Swimming and Oregon Swimming Inc., rules will govern this meet. "All applicable adults participating in or associated with this meet acknowledge that they are subject to the provisions USA Swimming Minor Athlete Abuse Prevention Policy (MAAPP), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition."

TECH SUITS:

No tech suits may be worn by any 12 & under USA swimming athlete in competition at any Sanctioned, Approved or Observed meet.

SAFETY:

Current Oregon Swimming Safety Guidelines and Warm-up procedures will be in effect and strictly enforced.

No swimmer will be permitted to compete unless the swimmer is a member as provided in article 302.

MEDICAL:

Current certified lifeguards and/or medical personnel will be on deck to assist any athlete or patron that is need. An aed and staff able to use will be available at all times during the event.

FACILITY:

The competition course has not been certified in accordance with 104.2.2C(4). Outdoor 25-yard pool with 8 competition lanes with non-turbulent lane lines. 8 warmup lanes available throughout meet. Automatic timing systems with touch pads and backup buttons. Swim venue includes Men's & Women's locker rooms with access onto pool deck. Facility is accessible to adaptive swimmers. The pools is 7 feet at the a distance of 3feet 3 ½ inches (1.0 meter) to 16ft 5 inches (5.0 meter) from both walls

CAMPING:

NO Overnight RV camping in the pool parking lots or parking lots adjacent to the pool. No parking or overnight camping will be allowed at Juniper facility. Tent camping is NOT allowed at or near the venue. There is pop-up tent available spots on site that must be removed daily. Pop-ups are not allowed to remain outside the pool facilities after the conclusion of the meet daily.

RESTRICTIONS:

NO ANIMALS ALLOWED INSIDE THE VENUE. TOBACCO PRODUCTS OF ANY KIND, ALCOHOLIC BEVERAGES, AND GLASS CONTAINERS ARE NOT ALLOWED IN THE SWIMMING VENUE. SHAVING IS NOT ALLOWED IN THE VENUE. USE OF AUDIO/VIDEO RECORDING DEVICES, INCLUDING CELL PHONES, IS NOT PERMITTED IN CHANGING AREAS, RESTROOMS, OR LOCKER ROOMS. EXCEPT WHERE VENUE FACILITIES REQUIRE OTHERWISE, CHANGING INTO OR OUT OF SWIMSUITS OTHER THAN IN THE LOCKER ROOM OR OTHER DESIGNATED AREAS IS PROHIBITED. PHOTOGRAPHY IS NOT PERMITTED BEHIND THE BLOCKS DURING STARTS AND RELAY EXCHANGES. OPERATIONS OF A DRONE OR ANY OTHER FLYING APPARATUS IS PROHIBITED OVER THE VENUE (POOL, ATHLETE/COACHES AREAS, SPECTATOR AREAS AND OPEN-CEILING LOCKER ROOMS) ANY TIME ATHLETES, COACHES, OFFICIALS AND/OR SPECTATORS ARE PRESENT.
