Final entry deadline is 5:00 PM, Thursday, May 9, 2024.

Event Limit: Athletes are limited to 3 individual events and 1 relay event per day.

Meet Limit: The 12 & Under morning sessions will be limited to 4 hours. Entries for Friday,

Saturday and Sunday afternoon sessions may be limited at the discretion of the meet director and meet referee. Saturday and Sunday afternoon session warmup and meet start times are estimates. Actual times for Saturday and Sunday afternoon sessions will be announced on the CAT website and via email on Friday, May 10,

2024.

Seeding/Check-In: AM Sessions

- Saturday and Sunday morning sessions will be pre-seeded and not subject to a no-show penalty.
- Events may be swum mixed gender at the discretion of the meet referee and meet director.

PM Sessions

- Friday, Saturday, and Sunday afternoon sessions will be deck seeded.
- Coaches are responsible for providing positive check-in at 3:15 on
 Friday and 30 minutes after the start of warmups for the Saturday and
 Sunday afternoon sessions. Any swimmer who fails to compete in an
 individual event for which he/she was positively checked in shall be barred
 from his or her next individual event. He/she will be permitted to participate in
 relay events of that day.
- Exceptions for failure to compete No penalty shall apply for failure to withdraw or compete in an individual event if the swimmer declares a false start with the referee prior to the start of the heat in which they do not compete.
- Heat sheets for deck seeded sessions will be published following the positive check-in deadline.

Bull Pen: A bull pen will be provided for 8 and under swimmers.

Timing: Daktronics timing system, horn start, and finish touch pads. Colorado or Daktronics

timing system with buttons or watches for 50 meter races. Results via electronic

scoreboard. Names will appear as received in meet entries.

of competition. Coaches' meetings will be held 15 minutes prior to the start of the Saturday morning and afternoon sessions; others to be

announced as needed.

Rules: Current USA Swimming, Inc. and Oregon Swimming, Inc. rules, including the Minor

Athlete Abuse Prevention Policy ("MAAPP") will govern this meet.

Uniform will be white over black with black shoes. If you will be attending, please

send your name and the sessions you will work to the Meet Referee at swimflygo@gmail.com. Hospitality will be provided for coaches & officials.

Timers: Each team will be assigned lane-timing duty. Signup sheets will be at Clerk of Course.

Facility: Competition Pool – 50 Meters, 8 lanes x 7-ft wide with 6-inch lines, Kiefer Freestyle starting blocks with grab rails and foot chocks. Depth: 3.5 to 13 ft. The facility will ensure that the course dimensions are as stated above.

25 meter, 6 lane outdoor pool available for warmup and cool down during meet. Medical facilities available include lifeguards, AED, and 911. The

facility will be open each day from 30 minutes before the start of

warmups through the conclusion of the meet.

Seating: Air-conditioned, sound insulated, balcony seating for 270 and marked spectator

seating on deck. Spectators are not allowed in the competition area - please observe

all posted signage.

Safety: Oregon Swimming Safety Guidelines and Warmup Procedures will be in effect.

> Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing racing starts or must start each race from

within the water.

• When unaccompanied by a member-coach, it is the responsibility of the swimmer or

the swimmer's legal guardian to ensure compliance with this requirement.

The competition area is restricted to swimmers, officials, coaches, authorized host

team volunteers, timers, and facility staff.

Restrictions: Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

No cameras or other recording devices are allowed behind the blocks.

Deck changing is prohibited.

 Operations of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

 No tobacco products, alcohol, or glass containers are allowed in the pool facility.









Restrictions cont.: • At the discretion of the referee and meet management, restrictions may be

placed on the deck and/or spectators to comply with facility, state, county

and/or local health or capacity regulations.

Concessions: Concessions by the Corvallis Aquatic Team will be available.

Camping: No OVERNIGHT CAMPING or RV's in the parking lots adjacent to the pool.

RV day-only parking available at Garfield Park, 2 blocks southwest of Osborn.
