Eligibility: Swimmers must be currently registered with USA Swimming. **No on deck meet registration will be permitted.** Swimmers must be within the listed age brackets as of June 29, 2024.

Entry Period: Entry acceptance period: Opens June 14, 2024 and Ends at **10:00am, Sunday, June 21, 2024**

Entry Limit: Each swimmer will be allowed to swim no more than 3 individual events.

Entry Fee: Swimmers Surcharge: \$6.00 (\$3.00 Oregon Swimming/ \$3.00 Host)
Individual Event Fee: \$2.50
Relays Fee: \$6.00
Facility Club Fee: \$20.00

Entry fees must be paid at the meet.

Entries

1. Submit YARD TIMES only for seeding.
2. Submit entries on Hy-tek Meet Management or Team Unify format via email to Entry Address. Please attach DOC or PDF of Hy-tek entries.

3. With submission of entries, the coach/team representative attests that all swimmers entered are registered with USA swimming.
4. Any swimmer entered in the meet must be certified by a USA swimming member-coach as being proficient in performing racing starts or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
5. Entries will be limited to adhere to the 4 hour rule. Breaks may be added at the discretion of the meet referee.

Tech Suits: No technical suit may be worn by any 12 & Under USA Swimming athlete in competition at a Sanctioned meet.

Check-In: **All events will be pre seeded**

Facility: Indoor, 25 yard pool with six, 7 foot lanes and STS timing system. Starting blocks at the deep end of the pool (6 feet). Shallow end 3 ½ feet. The competition course has not been certified in accordance with 104.2.2(c)4. Facility has accessibility for adaptive swimmers. Vehicle parking is available at Sheldon Community Center. Please use adjacent lot at Sheldon High School for RV parking.

Medical: The Facility will provide medical supervision to athletes in the form of lifeguards, Oxygen, and an AED.

Restrictions:

1. TOBACCO PRODUCTS OF ANY KIND, INCLUDING AND NOT LIMITED TO E CIGARETTES OR VAPE PENS. ALCOHOLIC BEVERAGES AND GLASS CONTAINERS ARE NOT ALLOWED IN THE SWIMMING VENUE.
2. Shaving is NOT allowed in the venue.
3. Pets, other than service animals, are NOT allowed in the venue.
4. Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms, behind the blocks. Photography is not allowed behind the blocks at any time during the meet. Operations of a drone, or any other flying apparatus, is prohibited over the venue (pool, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present
5. Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.
6. Cell phones or other recording devices are not allowed behind the blocks during the start of a race or relay exchange.
7. Operation of a drone or any other flying apparatus is prohibited over the venue (pool, athlete/coaches' areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Heat Sheets: Will be sent to the coaches to send out to families.

Safety Rules:

1. This meet will be governed by current USA swimming and Oregon Swimming Inc. rules.
2. Current Oregon Swimming Safely Guidelines and Warm-up Procedures will be in effect and strictly enforced by deck marshals, coaches, and officials.
3. All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (MAAPP), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
4. Locker rooms are for Athletes ONLY and will be strictly enforced.
5. All Applicable Adults under USA Swimming's MAAPP will have marked bathrooms/changing rooms.

Awards: Individual Events: Ribbons 1st – 6th

Meetings: Coaches meeting will be held 15 minutes prior to the start of the session. Officials meeting will be held 45 minutes prior to the start of the session.

Officials: We always appreciate the help of certified officials from other clubs. If you will be attending this meet, please notify the Meet Referee. All referees, starters, administrative officials, electronic timing officials, and stroke and turn judges, serving in an official capacity in this sanctioned event, must be members of USA Swimming, and all persons acting in any coaching capacity in a approved event must be coach members of USA Swimming. All coaches and meet referees must have completed annual concussion training.

Timers: Timing sign-ups will be posted at the start end of the pool.
