With submission of entries, the coach/team representative attests that all swimmers entered are registered with USA Swimming.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing racing starts or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

No Coach Present: For unattached swimmers, or swimmers whose coach is not attending the meet, it is the

swimmer's responsibility to arrange for a certified coach to be responsible for the swimmer. This must be done **BEFORE** the swimmer may enter the water for warm-ups or competition. Please see the Meet Director or the Meet Referee if assistance is needed,

upon arrival at the meet.

Facility: Indoor 25-yard, 13 feet deep, 6-lane pool

Relay legs starting from the 3'6" shallow end will do in-water starts.

The competition course <u>has not been certified</u> in accordance with 104.2.2[4]. Men's and women's locker rooms with access onto pool deck; Open pool deck areas available for

swimmers, coaches, and officials. Facility is accessible to adaptive swimmers.

Seating: Approx. 150 spectator seats. No dogs please!

Warm-ups: 10:30 - 11:55 a.m on Saturday and 8:30 - 9:55 on Sunday

Warm-up may be modified at the discretion of the Meet Referee to accommodate the

number of swimmers entered.

Meet Rules: Current USA Swimming Inc and Current Oregon Swimming Inc rules will govern this

meet. Current USA Swimming and Oregon Swimming Safety Guidelines and Warm-up Procedures will be in effect and strictly enforced. **The Facility will provide medical**

supervision to athletes in the form of lifeguards, oxygen, and an AED.

Timers: Teams will be assigned timing lanes at the start of the meet.

Concessions: Concessions available for food and drink.

Results: Will be posted at the pool and will be emailed to coaches upon request.
