The starting blocks are located at the deep end. Facility is accessible to adaptive swimmers. Timing is done with Colorado electronic timing system.

Parking is available but limited at Gold's Gym Camas. Swim venue includes: On deck Men's and Women's locker rooms and bathrooms for athletes only.

Check-in: Heat sheets will be made available to coaches and will be published to Meet Mobile at no charge. Heat Sheets will not be sold at the meet. Copies will be posted on the wall and a digital copy will be sent out the night prior to meet.

Awards: Top 6 finishers in each event from each age group will receive an award for both Male and Female. 8&Under, 9-10, 11-12, 13-14, 15+. The top three relays will receive awards for both 10&Under and 11&Over events.

Meeting: Officials meeting will be held at 1 hour prior to the start of the meet. Coaches meeting will be held 15 minutes prior to the start of the meet.

Safety: Oregon Swimming Safety Guidelines and Warm-up Procedures will be in effect. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing racing starts or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. No parents or non-competing children are allowed in the competition area (swimmers, timers, officials, and coaches only.)

It is understood and agreed that USA Swimming shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of this event.

Restrictions: No tobacco products, alcohol, or glass containers are allowed in the pool facility. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms, or behind the starting blocks. No cell phones or other recording devices are allowed behind the blocks. No deck changing. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. At the discretion of the referee and meet management, restrictions may be placed on the deck and/or spectators to comply with facility, state, county and/or local health or capacity regulations. The Meet Referee shall be the final authority for the conduct of completion.

MAAPP: All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
