INFORMATION

2022 10 & U Long Course Committee (created at the March 2022 OSI Board Meeting) to address low participation numbers because of COVID-19.

Committee members: Sheila Lovell-Otterstrom/TPC, Anastasia Kaldy/Athlete, Summir Case/Secretary, Alexandra Tokman/Age Group Vice Chair, Debbie Laderoute/OSI Executive Director

Committee met as directed by the Board of Directors to expand athlete participation at the OSI 10 & U LC Championship meet.

Members offered several options for discussion and arrived at the following:

ONE TIME CHANGE LIMITED TO 2022 10 & U Long Course Championship.

Meet Start Time – CHANGED TO 10 AM both Saturday and Sunday

Athletes must have at least One Oregon A qualifying time as entry into the meet.

Athletes with 1 Oregon A qualifying event, will be allowed 2 bonus swims.

Athletes with 2 or more A qualifying events, will be allowed 3 bonus swims, or as many bonus swims up to the entry limit for the meet (5 per day, 6 per meet).

Time Trials will be offered after the conclusion of each days timed final session, limited to 2 per athlete, per day.

At the discretion of the Meet Referee, lanes of competition may be adjusted to extend the number of heats for each event. Awards will be as usual, 1 award per the number of lanes of the facility.

Sanctions and scheduling clarifications April 2022

Purpose: In order to clarify two procedures that we have been passing along via historical knowledge to the scheduling and sanctions chairs but are not currently in our Policies and Procedures.

Article I Swim Calendar, Section II Scheduling chair duties

F. No sanctions will be granted for events happening on the same date as the OSI House of Delegates Meeting or the same date as the Oregon Swimming Top 5 Banquet, unless they are a planned part of these OSI events.

Under Article II sanctions, Section II procedures.

N. For swim meets that are held on the same dates as any of the OSI Championships:

• All events contested must have B/C time standards for entry (no A qualifiers allowed) if those events are being contested at the OSI Championships on the same weekend.

Other events offered at the meet are allowed without restriction.
