<u>USA Swimming - discontinuation of Officials Tracking System (OTS)</u>

OSI Officials Committee relies heavily on OTS to track officials. All LSC certified positions require training then testing. We track all sessions through OTS. Officials wanting to advance at the national level use OTS to show they have met the prerequisites to apply for advancement. It was recently announced by USAS that OTS is going away and there will not be an immediate replacement. OTS will not be accessible after August 31st, 2022 (when SWIMS 3.0 launches). Little information has been disseminated on how USAS will bridge the gap or an estimate on how long OTS will be offline. OTS is also tied to testing, we will not be able to certify new officials until a backup system or new OTS system is on board.

I would like to purchase a 12 month subscription to JotForms. This will allow us to continue to track LSC official's sessions worked by meet. This will support officials in their continued training and aspirations nationally. It will also be the least amount of work for meet referees on the reporting end. We would provide training at the mini-expo October 1st.
