Sr Chair Report -Shelly Rawding

The USA Swimming Workshop in the spring is now containing all the educational component that the USA Swimming convention used to provide in September. It was a very good and useful weekend spent in Denver. I encourage all eligible board members who are able to attend next year to do so.

Attached is an additional report on the notes from the LSC Leaders meeting. Definitely a lot of good ideas were shared on how other LSCs work out some of these areas that we can struggle with.

We are in contact with the Sr and Age Group chairs from Hawaii for our senior training trip. Thanks to Rick for working hard with Eric and Reid to help organize our fall trip. We should know soon

on the dates so we can begin firm planning for the trip.

And a few proposals for us to consider under new business:

To make our Policies and Procedures more accurate, I propose we change the wording from USA Swimming Convention to USA Swimming Workshop in our Policies and Procedures.

- a. Convention no longer exists. All education will be at the Workshop and all voting will be in September at the Annual Meeting.
- 2. Under Article VI- Section 1 E get rid of the words 'non-coach'. Have all delegates get paid the same for attendance at the Workshop.
- a. It used to be that OSCA paid coaches a stipend to attend convention, to help cover non covered expenses like food/transportation. With the transition from OSCA to the coaches committee, there is nothing in writing now that specifies coaches should be reimbursed for their attendance at the Workshop. Since the coaches are volunteering their time to attend this as officials and athletes are it makes sense to fund everyone equally.
- 3. There is now a Junior National Open Water Championships meet, so this should be added to

our travel fund table.

4. And a proposal to increase the amount of reimbursement for all of our travel reimbursements 10% for 2022. (inclusive of the Senior All Star Training Trip). a. With 8% inflation this year, and gas prices so high, travel this year is going to be much more expensive than in the past. It has been at least 5 years since we gave any kind of increase to these line items.

In April, Ellie and I got to attend the USA Swimming zone workshops in Colorado, and we had a blast! We made new friends and got lots of new ideas for fun things we can bring back to Oregon. Along with that, we are continuing our planning for the Leadership summit in August.

Workshop – I attended the SWIMS 3.0 workshop sessions in Denver. There are big changes coming with 2023 registration. They should be sending test links to registrars soon so that we can see parent and club views. There will be training sessions for clubs over the summer and the new platform will launch for the 2023 registration. With this new platform teams will receive unique links that they will then pass along to their families so that they can register with USA Swimming directly. Payment will still be processed at the club and LSC level. Important note for clubs - USA Swimming will consider the registration processed as soon as the registration is submitted by the family. Sanction procedures will also be changing. Sanction applications will be submitted through SWIMS 3.0 and USA Swimming will have complete calendar with all LSC information – we will continue to maintain our calendar on our website as well. OME (On-line Meet Entry) will be updated in time for fall as well but OTS (Officials Tracking System) will be down for at least a couple of months beginning in September.

Willamette University has been secured for the 2022 Top 5 ceremony.

We have begun planning for 2022 AG Zones. As previously noted, expenses have increased considerably across the board. Once Oregon Swimming contribution has been confirmed the applications will be made available. Coaching staff still to be confirmed.

At this time, we do not have bids for 2023 SC 10&U and Senior Championship meets. I have reached out to THPRD to inquire about the possibility of OSI renting the space for Senior Championships and will work with Britta to secure locations for both.
