Past Minutes

From the August meeting, Rex Watkins made a motion to approve the minutes with discussed changes being updated. Judi Creech second. August minutes were approved.

Treasurer's Report - Rhonda Soule

Attached is the preliminary budget for 2023 for your review. On Wednesday we can discuss, edit, and send on for approval at HOD. I was hoping to come up with a breakeven budget, but it doesn't appear that we're back to that point yet. The report also includes comparisons of budget to actual for 2021; and budget to projected (as of today) for 2022.

I made notes at the far right on lines where I'm proposing a different 2023 budget amount than what the current projection is for 2022. Officials' chair and athlete reps submitted their budgets to me.

Assumptions on other budget line items:

- 25% increase in non-champs meet sanction/surcharge/splash fee income
- 10&U SC & LC champs double the attendance of 2022
- 11-14 SC champs 25% increase in attendance (2022 was about 2/3 of pre-pandemic levels)
- 11&O LC champs 10% increase in attendance (2022 was about 85% of pre-pandemic levels)
- Travel expenses 35% increase for those meets that were before the approved board increase during 2022
- 25% increase to coach stipends for All-Star meets (has not been increased in several years)
- 5% increase to staff salaries

Russ Scovel make a motion to approve the budget to send to HOD. Jacki Allender second. Motion approved.

Time Standards - Sheila Lovell- Otterstrom	Sheila Lovell-Otterstrom reports participation has been down quite a bit with 12&U at championship meets. Put together a qualification time and eligibility update to OSI Policy and Procedures for a 3 years update process expiring in August 31, 2025. See screenshots below from the shared screen documents. Discussion took place. Sheila Lovell-Otterstrom would like to present this to the HOD with the support of the board. LSC Admins - Sheila Lovell-Otterstrom	From previous issues during the last 11&O, Sheila Lovell-Otterstrom would suggest that OSI add 3 administrators to the SWIMS database: Debbie Laderoute, Judi Creech (official's chair), and Rhonda Soule (treasurer) in regards of logging officials' data, having vacation coverage, and for emergency situations. Discussion took place about different levels of access. Debbie Laderoute stated that Judy Chen in the office has access as well and there are 4 security levels. Debbie Laderoute mentioned in the chat box that additional people can be added for access and we would not be limited. Sheila Lovell-Otterstrom asked if anyone would be interested in defining the different levels of access and drafting a letter for people who are not employees to sign, this will be looked into and presented at a following board meeting.	
OSI Board Retreat - Sheila Lovell- Otterstrom	General business, explanation of roles and responsibilities, and transfer between outgoing and incoming members to have the outgoing and incoming board members connecting on roles of the position. Discussion took place. Previous retreats took place in January and were helpful.	
TEAM Letter - Judi Creech	Judi Creech discussed how the letter needs to get wrapped up and sent as soon as possible. Committee to finish this by the next Friday, letter will be shared with the board, and will go out to TEAM on the next Monday.	
Updating Policy and Procedures - Judi Creech	Discussion on the updates/changes to Policy and Procedures getting corrected. Debbie Laderoute said she will do this.	
Uploading Results on new SWIMS 3.0 - Judi Creech	With SWIMS 3.0 host teams would be able to upload their own results. Discussion took place if OSI should continue to upload results and using HOD to educate teams about the benefit of OSI uploading results.	
Electronic Heat Sheet Fees - Rex Watkins	Rex Watkins remembered there was a committee to discuss if there would be heat sheet fees or not. Championship meets are allowed to charge these fees. Emily Melina said that Debbie Laderoute will send out a reminder to teams about not having the heat sheet fees included unless they are hosting OSI Championship meets.

I have talked to Rex and there is pool time at the Albany Y for a **B/C camp** focusing on starts for all ages on October 1st at the Albany Y from 8-9:30am. 

Motion – Qualification Time and Eligibility Update to OSI Policy and Procedures. <u>Three year</u> update process. Competition Years: 22&23 23&24 24&25. Expiration August 31, 2025.

Minimum 3 heats of athletes for each individual event at OSI Championships. (Senior Region XII excluded)

Required Changes:

- -Update to Policy and Procedures C & D.
 Add to C or by OSI invitation to equal 3 heats of competition per event.
 Strike from D "with the time standard never to become slower".
- -Update time standards to reflect athletes currently registered with OSI.

 Derive time standards using SWIMS data to back fill missing information caused by low participation rates. (Covid summer 2020-summer 2022).
- -Allow for additional athlete invitation using the times recorded in the SWIMS database.
