ELIGIBILITY:	Swimmers must be currently registered with USA Swimming. No on deck registration will be	
	permitted. Swimmers must be within the listed age brackets as of the first day of the meet.	









HOSPITALITY:	Hospitality will be provided for coaches and officials.				
SWIMMERS WITH DISABILITIES:	Swimmers with disabilities are welcome to enter this meet. The coach or team entry person must alert the meet director and the meet referee as to the need for any special accommodations or seeding arrangements at the time the entry is submitted.				
ENTRIES:	<ul> <li>Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing racing starts or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.</li> <li>Submit YARD TIMES ONLY for seeding.</li> <li>NTs will be accepted.</li> <li>Submit entries via E-mail in a Hy-Tek formatted file. Please mail entry fees and a printout of Hy-Tek entries.</li> <li>With submission of entries the coach/team representative attests that all swimmers entered are registered with USA Swimming.</li> </ul>				
ENTRY DEADLINE:	Entries will be accepted starting <b>October 16th at 10:00 AM</b> . Entries must be received no later than <b>11:59 PM on December 5th.</b> Entry Time updates will be accepted until <b>11:59 PM on December 5th.</b>				
ENTRY LIMIT:	Limit of 3 individuals and 2 relays per day on Saturday and Sunday. Friday there is a limit of 1 individual event and 1 relay. The Meet Director and Meet Referee may limit entries in any event or eliminate events in order to stay within a reasonable time limit.

NO COACH PRESENT:	For unattached swimmers or swimmers whose coach is not attending the meet, it is the swimmer's responsibility to arrange for a certified coach to be responsible for the swimmer. This must be done BEFORE the swimmer may enter the water for warm-ups or competition. Please see the Meet Director or the Meet Referee if assistance is needed upon arrival at the meet.				
WARM-UP:	<ul> <li>Warmup and session start times may change. Oregon Swimming Safety Guidelines and Warm-up Procedures are in effect at this meet. Warm-ups are subject to the following procedures:         <ul> <li>For warm-ups before the meet, each team will have an assigned lane to warm up their swimmers. There is a second small pool available for general warm-up as well. The small pool will also be available through the meet for warm-up and cool down.</li> </ul> </li> <li>Note: Swimmers violating safety procedures may be removed from the warm-up for the remainder of the warm-up session. Subsequent violations may cause the swimmer to be removed from the remainder of the meet.</li> </ul>

TIMELINE:	Warm-up times may change at discretion of the Meet Director and Meet Referee. All coaches will be informed of any changes to warm-up and competition times. The Meet Referee reserves the right to remove or lengthen breaks written in the sanction as deemed appropriate for the success of the athletes.	
	Entries will be limited to adhere to the 4 hour rule. Breaks may be added at the discretion of the meet referee. For individual events 400 yards and longer, heats may be limited to adhere to the 4 hour rule. Limits will be based on the order in which entries are received.	
	Due to the unknown number of athletes attending this meet, session timelines are tentative and subject to change. Once athletes are confirmed, a revised session timeline will be shared with all coaches prior to the meet and posted on TEAM Website.	
	Timelines are for reference only and the meet may be running ahead or behind the timeline. Swimmers are responsible for getting to their heat in time for the start.	
FORMAT	<b>Friday:</b> The 400 IM, 200 IM, 200 Free, and 500 Free will be swum fast to slow and mixed gender. The 400 IM and 500 Free will be deck seeded. Check in for all deck seeded events are due in the meet office 15 minutes after the start of warmups each day. <i>Relay change forms are also due in the</i> <i>meet office 15 minutes after the beginning of warmups each day.</i> Coaches are encouraged to report all scratches as early as possible.	
	<b>10&amp;U Sessions:</b> Timed finals events, separated by age group and gender. <b>Saturday and Sunday:</b> Prelims will be swum mixed age and gender. Finals will be split into 2 heats	
	of girls and 2 heats of boys by age group 11-12, 13-14, 15&O. Relays: Timed finals events, separated by gender.	
HEAT SHEETS:	Heat sheets and Psych Sheets with timelines will be available on the TEAM website in the 'Events' section prior to the meet.	
MEETINGS:	Coaches' meetings will be held, if needed, 15 min prior to the start of each session. Officials' meetings will be held 1 hour prior to the start of each session.	
TIMERS:	The meet will be run with two manual watches and 2 buttons per lane in addition to a fully automated timing system. We will need volunteer timers from each team.	
RULES:	Current USA Swimming and Oregon Swimming, Inc. rules will govern this meet. All walkways around the pool and lifeguard stations must be kept clear. Any act of theft, vandalism or similar action will result in immediate disqualification from the meet and the loss of any points accumulated toward team standings by the individual.	
	Oregon Scratch Rules will not be enforced for this meet.	
SCRATCHES:	Individual Events/Relays: Please declare false start before the event if planning on scratching.	
	Deck Seeded Events: Positive check in by coach/athlete will take place at clerk of course. If an athlete does not check in they will not be seeded into the event.	
	Finals: Any athlete qualifying for finals can scratch or declare their intent to scratch, within 30 minutes after qualifiers announcement. Please report scratches or intent to scratch at clerk of course.

RESTRICTIONS:	No Technical Suit may be worn by any 12 & Under USA Swimming athlete member in competition at any Sanctioned, Approved or Observed meet. Tobacco, non-tobacco, vapor products of any kind, alcoholic beverages, and glass containers are not allowed in the swimming venue. No shaving permitted in the venue. Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. Deck changing is prohibited. Please change in designated changing areas or locker rooms only. Photography is not allowed behind the blocks at any time during the meet. Operations of a drone, or any other flying apparatus, is prohibited over the venue (pool, athlete/coach areas, spectator areas and open-ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.	
SAFETY:	Oregon Swimming Safety Rules and Current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy ("MAAPP"), will govern this meet.	
	All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
