Treasurer's Report - Paul Windrath

Oregon Swimming's financial position is strong with revenues supporting expenditures on behalf of the Oregon Swimming athletes. All transactions are consistent with accepted accounting practices. With our admission to the LEAP 2 level of LSC Governance, managing to a QUAD budget (meaning forecasting and managing to a 4 year plan) will be increasingly important to ensure this strong financial position continues. Oregon Swimming Balance sheet is very strong and able to support modest initiatives without changing the revenue source calculations.

Revenue from Travel Fund Surcharges and Splash Fees, coupled with Registrations, continue to ensure expenditures are covered. The Travel Endowment will transfer about \$38,000 to the Oregon Swimming Operating Account in 2017 to support current and several new athlete initiatives.

Costs are rising in several significant areas: payroll and Championship pool costs. Swim Meet Revenue may be maxed out due to capacity constraints. Current interest rate environment means the annual transfer of funds from the Travel Endowment will remain flat at \$38,000 per year.

Later in the meeting I have requestioned that the HoD approval for the Quadrennial 2017-2020 Budget Forecast.

The Club Excellence Program was discussed, particularly changes for small teams - points are worth more for Gold (2x) and Silver (1.5x) normal point total. There will be a Podium Club - if a club has a Gold status for 4 years, they can receive additional grant monies.

Mitch Dalton (mdalton@usaswimming.org): Presentation on the Junior Team Program Gave background on if a female is in the top 75 internationally, 25% of these athletes make it past the Junior National team. If there is a male in the top 100 internationally, 25% of these athletes will make it past the Junior National team. There is a new quad plan (up on the USA Swimming website). The flow chart goes from

Zone Select --> National Select --> 100 world 18 & Under --> Junior National team
Zone and National select are National Teams while 100 world and Junior National teams are
international teams. Information on this is on the USA Swimming website.
It was brought up that the summer Olympics US Open is very small meet. The goal will be in 2020 to

somehow combine the Open and Junior National meets to form on meet.

Russel Mark: Olympic Review

There was a 63% improvement in times from Olympic Trials to the Rio Olympics (second only to Great Britain with 65%). 31 Olympic rookies - pretty normal numbers. All the swimmers on this team except two had prior International experience.

The keys to preparation were constant technical awareness and keeping the FUN factor. The head coaches told them that this is 'just another swim meet'. You don't need to swim out of your mind, you need to swim what you have trained for, and do what you normally do. There was an ability to take care of business regardless of distractions, and unprecedented level of attention on nutrition, strength, and sports medicine, especially with a full time dietician and strength coach on the staff. Fast and intense workouts at training camp with an engaged coaching staff. All the club coaches came and worked with their athletes at the first training camp in Texas. All the coaches were made to feel welcome and appreciated. Everyone got into the mindset of embracing challenges: the late night adjustment and optimism that they could do whatever it takes to be successful. At Rio, there was an ability to refocus daily: the USA team owned their area. They 'took up space' and used a cowbell to cheer for the person who was going off from the team area to their even with a cheer and the bell. They had a great culture, athlete leadership, and momentum.

Looking forward for continued success, what can we do? We can keep the goals processed driven not results driven, create independent and thoughtful athletes, be active as coaches and teachers, understand that success is around us, and to embrace our best athletes.

2020 Olympic Trials will be back in Omaha.

You can use USA coach mentorship dollars to send women coaches to the women's leadership summits. "Put yourself in the best place today and that will lead you to the best place tomorrow." She gave overview of how she got to where she is today.

- -What's your story?
- -Sell yourself.
- -Be concise and compelling.
- -Have a photo release on your meet sanction form.
- -Think before you post.
- -Create your own YouTube channel
- -Twitter/Instagram 2-3x/day
- -Videos over pictures, and smiling faces.

On Sunday, the 11-12 Boys 50 BR in front of the girls 50 BR to make the flow better. And an hour and a half for warm ups for finals. Clarification on check-in vs. scratch in the meet information.

10&Under meet went very well. Albany ran a great meet. 200 FR and 200 IM were switched in the meet information.

Website/Records - Robbert van Andel

Records: The final records of the season have been submitted to the office. Certificates will be made for the awards ceremony. One housekeeping item that needs to be done is the standing rules do not accurately reflect the rules set up by the HOD about 10 years ago. At a past HOD, the rules were set that records were to be set by a swimmer representing an Oregon Swimming registered club or a USA Swimming national team. This was never included in the standing rules.

Officials Committee Report - Julie Carpenter

The official's clinics yesterday 10/01/2016 were very well attended especially considering the travel involved in attending. There were approximately 30 officials. Cecil Gordon's (National Starter with the Swimposium) clinic was excellent! His knowledge and experience also added many good contributions to the other clinics.

Jim Quisenberry, the Area Chair for Eugene Area has stepped down. Bill Shreeve has agreed to take on that role.

As of October 1st, ten officials have attended various National Meets with partial funding. 2 National Evaluators visited in 2016: Kathleen Scandary from Colorado in March, and Jason Johnson from Texas in July. Mentored officials to help them reach a national level quality. There is a definite shortage of officials at LC Championship meets. There were no S&T judges at 11&Over Championships and Sectionals. It is critical to get more parents involved. This is a problem throughout the U.S.

Updates and Reminders:

- * Tie Back Suits: the current rule states suits need only comply with FINA rules and need not carry the FINA approved logo. FINA rules prohibit competition suits with fastening systems. A competition suit with lacing or a tie back is deemed to have a fastening system and therefore prohibited. However, these suits may still be worn during warm-up or cool-down.
- * Dive Certification: All clubs must ensure that all team members are certified and that coaches understand and comply with the certification process. Failure to do so could jeopardize club and coach insurance coverage. If not dive certified, an athlete must start the race in the water.
- * Go Pro Cameras: More parents are wanting to use them during meets (in the water). I consulted Jay Thomas, the USA Swimming Rules Committee Chair, we should not allow this during competition. Use of Drones is not covered by insurance.
- * Registered Meet Directors: USA Swimming requires that meet directors be registered.
- * Deck Changing: Reminder that this is not allowed. We want to use the educational approach and the coaches need to be involved.
- * DQ slips: These can be ordered online through USA Swimming and will be delivered to you in 2-3 days. The ship through Swim Outlet.
- * Deck Pass: The app has been deemed an acceptable form of credentials on deck.
- * Kinesio Tape: The tape is not permitted in USA Swimming. It is permitted for use in HS Swimming with a letter.

Question: If they can do, say a kneeling dive, can they do a kneeling start off the side? Swimmers must be completely dive certified to do any kneeling dive, block dive, etc. If they have not been dive certified they must start in the water.

Sanctions Chair - Reed Sloss

Please send in November and December meet sanctions.

173 sanctions have been awarded both in 2015 and 2016 since the last delegates meeting (compared to 201 sanctions in 2014/2015). this 173 number comes from 89 open/invitational/championship meets, 11 dual meets, and 7 intrasquad meets. This compares to 119 regular, 16 dual, and 6 intrasquad meets during the previous annual period. The 173 sanctions also included 10 time trials and 4 Approvals. Altogether, \$4,990 has been collected (or in the process of being collected) in sanction fees, compared to \$5,785 collected in 2014/2015. Changes to Meet Documents:

1. Under RESTRICTIONS Section:

Oregon Swimming Inc:



Mission Statement: To build and promote the sport of competitive swimming for the benefit of all swimmers to achieve their maximum potential. "Changing into or out of swimsuits other than in locker rooms or designated areas is prohibited" is replaced simply by "Deck changes are prohibited."

2. Also under RESTRICTIONS Section add the following:

"Operation of a drone, or any other flying apparatus is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present."

Exceptions may be granted with prior written approval by the Vice President of Program Operations.

Safe Sport - Joe Dahl

In March, USA Swimming started Safe Sport Monday. Each month coaches receive a scenario with questions attached to talk with swimmers. It has received positive reviews. More parents and swimmers need to take the athlete protection training. A Safe Sport liaison for each club to help awareness. USA Swimming Safe Sport Fellowship is available for athletes, it is a fellowship to attend 3 different conferences throughout the year to discuss safe sport and give information to LSCs, clubs, etc.

NTV Chair - Jacki Allender

HS Coaches please put in USA Swimming numbers to transfer times into the database. Non-HS Coaches please get the USA Swimming numbers to HS coaches to facilitate transfer of times. HS Federation has declared that deck changing is not allowed and will be a non-sporting conduct which disqualifies swimmers from the rest of the meet (including if they made finals in an event).

Zones was held in Kearns, Utah and fun was had by all. Besides a little drizzle and one lightning storm weather was perfect for some fast swimming. Out of the 48 athletes representing Team Oregon we had 41 athletes who qualified for either an A or a B final, bringing major points to Oregon. Out of those 109 finals swims there were several Zone champion swims and a ton of kids moving up spots from their seed time. 19 of Oregon's 32 relays also scored in the top 8 position. Overall Oregon finished 6th place at the meet!

Location: OSI Bylaws page 14- Article 604.1 Members

Proposed by: The Athlete Representatives

Purpose: To return the election of the Junior Athlete Representative to the Athletes.

Effective date: Immediately

Athlete Representatives - Two (2) Athlete Representatives shall be elected, one each year for a two-year term, or until their respective successors are elected. The election of the Junior Athlete Representative will open January 1 and close at midnight PST on the 3rd Monday of January. The Athlete Representatives of OSI member clubs, the current Junior and Senior Athlete Representatives, as well as any At-Large Athlete Representatives, and the Area

Athlete Representatives shall be eligible to vote for the Junior Athlete Representative. The Athlete term of office shall begin February 1. At the time of election, the Representative must (a) be an Athlete Member in good standing; (b) be at least sixteen

(16) years of age or at least a sophomore in high school; (c) be currently competing, or have competed during the three (3) immediately preceding years, in the program of swimming conducted by OSI or another LSC; and (d) have his or her permanent residence in the

Territory and expect to reside therein throughout at least the first half of the term (Other than periods of enrollment in an institution of higher education). At least two additional At-Large Athlete Representatives shall be elected. At the time of election, the At-Large Athlete Representatives shall comply with (a), (b), and (d) above. At-Large Athlete Representatives may meet the conditions for (c) above, or have represented OSI or the United States in competition within the ten (10) years preceding their election. The election will be held at the annual OSI House of Delegates when other elections are held. The At-Large Athlete Representatives will serve until their successors are election. Additional At-Large Athlete Representatives shall be elected to satisfy the minimum 20% athlete representation requirement.

Derivation - The "A" time standard for each gender and age-group are derived by averaging the 24th place time (18th place if Championship meet held in 6 lane pool) over the past three years, with the standard never to become slower. An exception may be made for LC 15 & Over standards that are faster than Senior Zone standards (rate of .05/50). "B" time standards are derived by multiplying the "a" time standard by 110%. B+ Derivation: halfway between A and B Time Standards.

Notes from Convention

Due to the proposition put forth of restructuring the USA Swimming Board of Directors, many talks had discussion points on this topic. The biggest question put forth that had to be answered was on representation. People that were against it were worried about how their geographic area will be represented in the future by USA Swimming. After a lot of talk and the vote at House of Delegates, the measure when voted on passed by a fairly wide margin.

At the coaches meeting, discussion was on insurance. If you are looking into healthcare insurance, you can go to www.usaswimming.org/insurance and that will take you to the marketplace where you might find better rates than searching on your own. Some people said they were much lower, others said they were about the same as other programs they checked out.

Also, George Block said the World Swimming Association has adopted their initial constitution. Membership is only \$5 per coach, and they would like everyone to join www.worldswimming.org

If you are interested in a National Committee Position, be sure to apply online by October 1st. https://fs22.formsite.com/usaswimming/form3/index.html

From athletes mentoring - In working to ensure athletes have a bigger say on your team and in the LSC, it is important that you are intentional about athlete mentoring. Make them a 'toolbox' with documents in it for their terms, how voting in members happens, job description, how to run elections, how to run a meeting. You need to give athletes information and templates on how to do these things. Cannot assume they know how to do this already. Use camps, workshops, meetings.

Figure out the communication system that works. How do our athletes communicate with each other? What works? What doesn't? Don't assume everyone checks email – and there are so many social media outlets that not everyone uses the same one.

From coaches mentoring ideas – lots of great ideas presented. One great new idea - using round tables mentor led discussions (think of this as 'speed dating' for coaches) Between sessions at a swim meet, find a mentor to lead a quick discussion of one topic while everyone eats lunch. Quick coaches education. Can also use an incentive system from the LSC. Had the opportunity to talk to other LSC's that have had great success with using those mentorship dollars.

For LSC/club organization

Use resources such as DropBox to keep documents in for access by members.

Strategic planning is the Yellow Brick Road for staff

Sustainability – handbooks, etc...

Write down your 'legacy'. What do you always do, but it isn't written down anywhere? Write down the information so it gets passed down to new board members.

Organizational charts for your staff/board. Who reports to who and share this information so everyone knows how it works. What is your chain of command? Data/reports how frequently? Duties/responsibilites. Create a chart with board positions, start date, term, name, contact information. Also a flow chart of how the organization works.

Annual performance reviews – compare against job description and goals/objectives of projects. Conduct this professionally, with 2 or 3 person committee. Have employee evaluate themselves then use this as talking points. Take input from stakeholders.

Lots of discussion on what makes good communication, organization and other important business skills.

At Western Zone meeting elections were held for Non-Coach Zone Director. Dale Ammon from Colorado was elected, but there were three very qualified candidates this year (also Denna Culpepper from SN and Jim Patterson from CC). The Championship meet coordinator position was voted on and Cathy Vaughn from UT was elected. Also Debbie Baldwin (SDI) was voted in for Secretary/Treasurer.

They decided to allow the Age Group Zone meet to move to an earlier weekend if the host team wished to move it earlier. (I spoke against this move – I think it will be a big detriment to the meet if it starts moving around weekends) It can now be held within a three week range of weekends from the Wednesday before the last Saturday in July to the current weekend of the Wednesday before the 2nd Saturday in August.

Approved was a 'gate fee' charge for the Age Group Western Zone meet, so that will help with bringing in income to the meet from spectators.

Oregon Swimming bid on hosting the meet at Mt Hood Community College in 2019 and was awarded the bid. We last hosted this meet in 2008.

The LSC Development committee was pleased to introduce a way for LSC's to earn \$1000 – by hosting a Bright Ideas contest. Submissions from LSC's can be made now thru June 1st, with the winning 'Bright Idea' to earn that LSC the \$1000 grand prize. All submissions are encouraged to have a poster in the posterboard display in next year's Vendors Hall. Entry categories are Business, Volunteer, Club/Coach and Athlete. The LSC Development committee is encouraged by the early interest in this program, as before convention was over they had already received a submission in the contest.

The Athlete Leadership panel gave great ideas on Empowering and Engaging Athlete Leaders. 5 LSC's gave testimony on how they brought athletes into their LSC's and clubs. San Diego Imperial discussed the way they created a manual for their athlete leaders. Illinois discussed how they defined success by their athlete leaders and how that has improved their function. Michigan has used an athlete committee to lead the charge within their LSC, they have established a budget line item for their committee and use that money to develop athlete specific programming. Arizona's been working on creating athlete training/leadership which on their first year had 40 athletes come to learn what it meant to be an athlete representative. The athletes are also working on bringing back a rotating 4 Corners meet for the 4 Corners LSC's. And Gulf Swimming put together a weekend long camp for leaders through their LSC focused on developing leaders in the LSC and well as giving athletes the skills they need to be leaders outside of the sport.

At the House of Delegates meeting, all motions presented were passed.

The Oregon contingent did a great job gathering together and sharing the information from the talks they went to. We usually met for lunch, and one group dinner, with other times of meeting and discussing topics. I think we all came away energized and enthusiastic about this next year.

Age Group Report

Tech Suit Update:

USA Swimming hired a consultant to advise them on tech suit policies for age group athletes. OSI decided against having a formal policy and instead chose to simply recommend its athletes to not have 10&Us wear technical suits. Having a policy put undue amount of work on our already busy Meet Referees. USAS will continue to look into this issue and OSI will follow any policies they may adopt in the future.

Diversity Report:

USA Swimming recommends not using free and reduced lunch as a standard for outreach membership as many subsidized lunch programs have changed over the years. Instead they recommend adjusting your LSC policy to something that ensures you're reaching the right outreach athletes.

OSI Outreach Policy

Athletes with families eligible for Oregon Trail (EBT/food stamps/SNAP for Washington members) will be eligible for USAS Outreach Membership for 5\$. A copy of the card/paperwork proving card is for the member will suffice as proof for registration. The Oregon Trail/Basic Food card program requires members to make no more than 185% of the poverty level (they are required to show tax returns and proof of income to DHS) so this prevents OSI from having to process sensitive information/documents.

Safe Sport is the first program to host its content on LEARN, however other programs will soon have courses available.

- Need total of 75 points
- Everyone must take equivalent of Safe Sport 101 (50 points)
- Choice of 2 other courses worth 25 points each (can take both)
- Total time for both courses approximately 45 mins
- Must put in your address to check out when you "purchase" the courses (0\$) but only the first time that you check out with LEARN.
- Will save spot based on log-in can log-in from any location/device to get back to the same spot
- Must complete the course evaluation to complete the course

OSI Sanctions Chair Report for OSI Delegates Meeting October 1, 2017

Activity: 191 sanctions have been awarded both in 2016 and 2017 since the last delegates meeting [compared to 173 sanctions in 2015/2016]. This 191 number comes from 99 open/invitational/championship meets, 18 dual meets and 6 intrasquad meets. This compares to 89 regular, 11 dual and 7 intraquad meets during the previous annual period. The 191 sanctions also included 10 time trials and 4 Approvals (same numbers as 2015/2016). Altogether, \$5,420 has been collected (or in the process of being collected) in sanction fees [compared to \$4990 collected in 2015/2016].

Updated Sanctions Application Packet (coming soon): Following updates to the OSI Standing Rules / Policies and Procedures, the Sanction and Approval application forms will have besides the Meet Referee assigned to run the meet, an additional line for identifying the certified Administrative Official. The meet document must also include the name and email address of the Administrative Official. Optional text may be included in the meet document at the discretion of the club hosting the meet:

Priority for entries may be given to those teams that commit to provide officials based on OSI Suggested Standard:

- 0 to 5 athletes entered in a session: No need to provide officials.
- 6 to 20 athletes entered in a session: 1 certified official per session
- 21 or more athletes entered in a session: 2 certified officials per session.

Section II- USA Swimming National, Futures, Zone, Open Water and Disability Championships

A. Purpose – To reimburse part of the travel costs of OSI swimmers and coaches competing in/attending USA Swimming Senior/Junior National, Olympic Trials, Futures, Open Water Nationals, Western Zones, and Disability Championships or members of OSI clubs who are members of USA teams in international competition when said championships are outside OSI boundaries.

B. Allocation and Distribution of Funds

- 1.Allocation Funds for Championship travel shall be derived from the swimmer surcharge and a portion of individual/relay entry fee(s) collected from OSI sanctioned competitions plus any funds or donations obtained for the specific purpose of supporting authorized Championship travel. OSI may elect to allocate additional funds from other sources, including all fines collected for proof of time penalties, late reports, etc.
- 2. Distribution The ratio of reimbursement shall be calculated so that JR meet participants receive approximately 75% of the amount allocated for SR meets, adjusted for location factors. Members of OSI clubs who are members of USA teams in international competition shall be reimbursed at the SR rate. Open Water National meet participants will be reimbursed at the SR rate. WZ Meet participants will receive lesser amount as shown in the table below. Notwithstanding anything to the contrary in Article V, Section II, c, 6; for Relay Only swimmers each club will receive 25% of the reimbursement listed in the table following Section II, b, 2 for each relay-only swimmer, who competes at the meet, up to a maximum of four relay only swimmers for the meet.

248 swimming for the benefit of all swimmers to achieve their maximum potential" – is best served

by a Zone Team that creates opportunities at every level of Oregon Swimming for athletes to

achieve competitive excellence and success at the Western Age Group Zone Championships.

251 This necessitates serious consideration of returning the opportunity of Zone Team membership to

252 Oregon's 10&U athletes.

Observation #1:

The addition of a 10&U squad of up to 12 athletes, plus one dedicated 10&U Coach, and one

dedicated 10&U Chaperone (Budget Options #3&4) is both financially feasible and cost-

effective for both Oregon Swimming and Oregon Athletes.

Observation #2:

- Out of 17 LSC's at the 2017 AG Zone Meet, Oregon was the only LSC that did not have 10&U
- 270 athletes competing as part of the LSC Zone Team. The inclusion of 10&U athletes on the Oregon
- Zone Team creates the opportunity for these athletes to gain valuable travel team experience in
- an atmosphere of competitive excellence. These are experiences that all Zone Athletes bring
- back to their teams, which in turn raises the level of excellence of age group swimming in
- 274 Oregon.

Observation #3:

- 277 The focus of the Age Group Zone Meet is moving in the direction of a high-level championship
- event, with such changes as skits and games being moved to either before or after the meet itself,
- 279 live streaming of the event potentially being added, and the scoring of relays being extended to
- 280 top 16, as with individual events.

Observation #4:

- Oregon's 48 athletes earned a total of 1108 points, with 99 Top 16 finishes, of which 47 were
- Top 8, and 7 were Top 3 including one first place finish.
- The theoretical addition of a 10&U squad, comprised of the top 6 10&U girls and top 6 10&U
- boys from the 2017 OSI 10&U Summer Championships, demonstrates the competitive
- 287 excellence of this group these 12 athletes would have scored an estimated 477 additional
- 288 points, including three first place finishes, 4 second place finishes, a total of 22 Top 8 finishes,
- and a total of 40 Top 16 finishes. With these 10&U athletes as part of Team Oregon, the final
- score would have easily placed Oregon as high as 5th, and potentially 4th, or even within reach of
- 291 3rd place. Having a team score that is truly reflective of the level of competitive excellence of
- Oregon's athletes is an honor that every Team Oregon member proudly contributes to achieving.
